

Jug Bay Classrooms In The Field **Bus Scholarship Guidelines & Application Procedures**





Jug Bay Wetlands Sanctuary (JBWS) offers outdoor learning opportunities for pre-K-college students. Exploring the Sanctuary's varied habitats and inhabitants, students build environmental knowledge, learn through experiential opportunities, and are encouraged to expand their comfort zones while making personal connections with nature. Studies show children who are connected to nature have better health, a higher satisfaction with life, and exhibit pro-environmental behaviors.

Thanks to the Friends of Jug Bay (FOJB) and generous funders, Jug Bay Wetlands Sanctuary awards schools full and partial bus scholarships to help cover transportation fees. Teachers and non-profit organizations that serve Title I students in the state of Maryland and those in need are invited to apply. Bus scholarships are limited to one award per calendar year, and funding is for buses only and cannot be used for other modes of transportation. Submitting a Bus Scholarship Application form does not guarantee a scholarship award.

SCHOLARSHIP APPLICATION GUIDELINES

- One award per class/teacher, per calendar year.
- Must serve Title I students within the state of Maryland or demonstrate financial need.
- Field trip must be scheduled and confirmed with JBWS Education Staff.
- Sumbint a separate letter of need/intent which includes the amount requested.
- Submit a school district itemized bus transportation invoice or official quote for the bus, which shows: trip information, payment information, and the cost of the bus in advance.
- Requested amounts exceeding \$500 will need further review by the Friends of Jug Bay before a decision can be granted. Expect delays in your decision.
- Incomplete bus scholarship applications will not be considered.
- Submitting a bus scholarship application form does not guarantee a scholarship award.

RECIPIENT INFORMATION

If awarded a scholarship, you will receive an award letter with the amount granted to the email address indicated on your CITF application. FOJB will arrange and submit payment directly to the bus company.

CANCELLATION POLICY

Bus scholarship recipients must cancel or reschedule a group as soon as possible. Since we pay the bus company directly, it is an involved process to refund this money. Failure to provide adequate cancellation notice will affect future reservations and scholarship considerations for your school/organization.
